OP&F's investment portfolio value: Value as of May 25, 2022 is **\$18.1 billion**.

You will notice a new logo and color scheme when you are visiting the website and any future mailings that will be sent to you about your health care reimbursement information. To avoid any confusion OP&F's logo will be on any correspondence from ALIGHT.

## Legislative News



As you know, it is a unique time in Ohio politics and public policy as voters await a definitive primary election date for their state legislators. This is following a lengthy back-and-forth between the Ohio Redistricting Commission and Ohio Supreme Court on the validity of Commission-drawn state legislative district maps. While August 2<sup>nd</sup> looks to be the date for this unprecedented, bifurcated Ohio primary election cycle; local boards of election will face a quick turnaround to prepare for the November general election.

The Ohio 134<sup>th</sup> General Assembly was back in session through the beginning of June to finalize a host of legislative issues prior to summer recess and the state legislative primary and general election campaign season. Our team at Byers, Minton & Associates is closely monitoring several pieces of legislation and regulatory activities being that will directly and indirectly impact you as a Police or Fire Retiree.

### Legislation Watch

On March 30<sup>th</sup>, Ohio Police & Fire Pension Fund Executive Director Mary Beth Foley testified in support of House Bill 512, sponsored by Republican Representatives Brian Baldridge and Cindy Abrams, and aims to incrementally increase over a 5-year period the employer contribution amounts of full-time firefighters and municipal police officers made to the OP&F Pension Fund. Currently, the contribution rate for employers of firefighters is 24% and for police officers, 19.5%. If passed into law, the employer contribution rate for both professions would increase to 26.5% by 2027.

Director Foley highlighted the importance of this legislation as vital to pension modernization, to avoid a

future funding crisis, and protect the pensions of our first responders. The Director cited the benefit cuts, capped COLAs, increased retirement ages, the pandemic, and rising as some of the factors considered when considering the need for HB 512. Employer contributions have not changed in nearly 40 years, and proponents of HB 512 note the legislation is intended to responsibly practice good government and avoid future crises.

The legislation has received two committee hearings in the House Insurance Committee and will likely be considered further this legislative session.

### Ohio Retirement Study Council

The Ohio Retirement Study Council has seen recent member changes following the departure of former Chairman Rick Carfagna, who took a position with the Ohio Chamber of Commerce. Representative Carfagna was replaced by now-Chairman, Representative Phil Plummer (R-Dayton), the former Montgomery County Sheriff.

Additionally, Representative Adam Bird (R-New Richmond) and Representative Mary Lightbody (D-Westerville) have been appointed to serve on the Council, and we look forward to reintroducing Gary, the PFRO Board of Trustees, and the broader membership to these new appointees.

The Council has spent the last several months reviewing the pension systems investment year closing out 2021 and how the funds are navigating the requested divestment from Russian assets, given the ongoing conflict in Ukraine. Divestment is easier said than done, especially with the closing of the Russian stock market, but Pension System representatives continue to work with legislators on strategies around divestment while maintaining their fiduciary responsibility.

### Federal Social Security Fairness Act of 2021

In coordination with your PFRO leadership, we are also in the process of reaching out to our Ohio Congressional delegation in support of the bipartisan H.R. 82, The "Social Security Fairness Act of 2021." The legislation would repeal both the

Windfall Elimination Provisions (WEP) and the Government Pension Offset (GPO) under current Social Security Law. The WEP creates a system which does not recognized the rightfully earned Social Security Benefit and public pension benefit and remain severely flawed in practical application. H.R. 82 has over 250 co-sponsors including half of our Ohio Congressional delegation (8 members), and we are encouraging others to support the proposal as well.
