Please allow me to introduce myself. My name is **Gary Siniff** and I am a retired Franklin Township Firefighter. Currently we are evaluating / reviewing the membership rolls of our organization. As Vice President of the 5th District of the Police and Fire Retirees of Ohio, I want to thank each of you who have demonstrated your support to our organization through your continued membership.
