Dear PFRO members,

We will be brief and blunt. Our PAC (Political Action Committee) is in serious jeopardy of running out of money. We have less than \$10,000 presently and money is not coming in at a very fast pace.

Your leadership has been very busy working with the OP&F Pension Fund Board, spending much time in trying to work with them on health care, Medicare supplements, and other important matters (Medicare Part B reimbursements and a COLA reduction).
