I would like to thank those members who were able to attend the OP&F Pension Board meeting held on May 17, 2016.

Many of those members had their eyes opened. They listened for nearly two and a half hours while the consultants gave their second report on their recommendations concerning our health care. While a discussion was held on all thirteen points in the report, no action was taken at this meeting. However, a decision must be made at the June 28, 2016 meeting so that these changes can be implemented for the 2017 annual change period. Remember these changes being considered will affect all our members to different degrees. We will need your help to try to minimize any changes that the board members will be making at this meeting. So once again I am calling for your support. Those of you that can make it please make the effort to attend the June 28th OP&F Pension Board meeting at 10:00 am, 140 E Town St, 7th Floor, Columbus, Oh 43215. This will be our last chance to make a difference

As of May 18, 2016, these changes will take place in 2017.

- Prescription plan premiums will increase 5.8%
- > NonMedicare eligible: UHC
  Healthcare premiums will increase
  3.2%
- Medicare eligible: Any increase to AARP Medicare supplements will be announced

later in 2016

Some of the benefit options to be discussed for changes in the 2017 year will be as follows:

➤ Increase Rx copays - \$15/\$50/\$100

- Add fourth tier of Rx coverage with 50% member cost share up to \$300/script
- Implement coinsurance on all specialty pharmacy
- Increase Emergency Room copayup to \$200 per visit
- Increase deductibles -

In-Network Deductibles - \$750 for individuals/\$1,500 for families
Out-of-Network Deductibles - Increase to 3 times current level

➤ Increase coinsurance limits In-Network - \$2,000 for individuals/ \$4,000 for families

*Out-of-Network* - Increase to 5 times innetwork's coinsurance limit

- Increase specialist copay
- Increase inpatient copay to \$400 per admission
- Implement narrow pharmacy network offering - Only allowing one pharmacy choice with some exceptions
- Reduce/cap Part B premium subsidy - to reduce completely or cap current Part B down to \$96.40 per month
